Sled condition – your snowmobile must be properly prepared for the trip. BVSA will provide a checklist of items to be serviced prior to the trip. Bringing an unprepared sled is not fair to others on the trip.

We may cancel or modify a trip due to conditions and issue a refund to clients. If the trip is extended due to events, the client agrees to pay the daily rate for additional day/days.

A criminal conviction including DWI within last 5 years may result in denied entry in to Canada.

To insure the safety of the group, the trip guide reserves the right to expel from the trip, any person or persons engaging in behavior the guide deems to be disruptive or unsafe. There are no refunds in this event and the expelled party is responsible for the costs of returning to point of origin.

Terms and Conditions:

Important: You are participating in an adventure trip with risks and uncertainties, including but not limited to; poor weather conditions, snow and trail conditions, mechanical malfunction of the equipment and unforeseen events both natural and man-made. If it is your desire to remain in control at all times, you are most likely not suited for this type of trip.

A non-refundable deposit of \$250.00 USD per person is required to reserve trip.

The full payment is due 30 days prior to departure. The "contact" for a private trip must collect payment from each member of the group and forward the payments as a whole to BVSA.

The exchange rate of the U.S. - Canadian dollar is a factor in determining the cost of trip and as such the final cost is subject to adjustment.

In consideration of the services of Bonvoyage Snow Adventures, their agents, owners, officers, volunteers, participants employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "BVSA"), I hereby agree to release, indemnify, and discharge BVSA, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

- 1. I acknowledge that snowmobiling entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to me, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. _____ Initial here

The risks include, among other things: riding on uneven snow covered terrain, changing snow conditions and variations in elevations; loss of control of the snowmobile, falls from the snowmobile, collision with other snowmobiles, participants, trees, rocks, and other manmade or natural obstacles; exposure to the elements, extreme temperatures, inclement weather and encounters with animals and wildlife; burns; and mechanical and/or equipment problems and unavailability of immediate medical attention in case of injury. _____ Initial here

Furthermore, Bonvoyage Snow Adventures LLC (BVSA) employees have difficult-jobs to perform They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

- 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks. _____ Initial here
