Quebec Trail Permit:

The procedure for obtaining a trail permit has changed. **ALL permits are only sold online.**

The trail permit can only be purchased by the registered owner of the snowmobile; an account must be created in his/her name. Accepted online payment methods: VISA or MasterCard

The transaction is carried out on a secure site and no information related to your credit card will be retained once the transaction is complete.

Step 1 - go to <https://fcmq.qc.ca/en/trail-permit/line-trail-permits/>

Step 2 - click on "But a trail permit", then create an account

Step 3 - provide year, make, model, plate number & VIN of snowmobile, click "buy permit"

Step 4 - in box asking for club number enter 201 (excellent snowmobile club)

Step 5 - find enhanced sled icon on map below and click on it

Step 6 - pick season, weekly or daily permit

Step 7 - provide credit card information, click purchase

Step 8 - save & print temporary pass for use before permit arrives

Step 9 - receive trail pass (for USA buyers, plan on arrival in 3 weeks)

Terms and Conditions:

You acknowledge that you have been informed of the riding and other demands of the trip and agree that if you are unable to safely maintain the schedule of the tour, you must leave the tour. _____ **Customer initial**

Alcohol – You agree not to consume ANY alcohol or drugs before riding a sled on our trips. If you violate our zero-tolerance policy at any time, you will have, without further notice from BVSA, automatically removed yourself from the tour. If you cannot abstain from having a beer with lunch, please do not join our tour. _____ **Customer initial**

Sled condition – Your snowmobile must be properly prepared for the trip. BVSA will provide a checklist of items to be serviced prior to the trip. Do not bring an unprepared sled to our tour.

BVSA may cancel or modify a trip due to conditions and issue an appropriate refund to clients. If the trip is extended due to events, you agree to pay the daily rate for additional day/days.

Legal – You agree to pay all costs to collect monies due BVSA including reasonable attorney's fees and court costs.

A previous criminal conviction including DWI will likely result in denied entry in to Canada.

You will not threaten or harass BVSA guides or staff under any circumstances. You will not discuss politics, world events or other inflammatory subjects while on our tour. To ensure the safety of the group, the tour guide reserves the right to expel from the trip any person or persons engaging in behavior the guide deems to be disruptive or unsafe. There are no refunds in this case and the expelled party is responsible for the costs of returning to point of origin.

Important: You are participating in an adventure trip with risks and uncertainties, including but not limited to; poor weather conditions, changing snow and trail conditions, mechanical malfunction of the equipment and unforeseen events both natural and man-made. If it is your desire to remain in control at all times, you are most likely not suited for this type of trip.

A non-refundable, non-assignable deposit of \$500.00 per person is required to reserve trip.

In consideration of the services of Bonvoyage Snow Adventures LLC, their agents, owners, officers, volunteers, participants employees, contractors and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "BVSA"), I hereby agree to release, indemnify, and discharge BVSA, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

- 1. I acknowledge that snowmobiling entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to me, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Initial here

The risks include, among other things: riding on uneven snow covered terrain, changing snow conditions and variations in elevations; loss of control of the snowmobile, falls from the snowmobile, collision with other snowmobiles, participants, trees, rocks, and other manmade or natural obstacles; exposure to the elements, extreme temperatures, inclement weather and encounters with animals and wildlife; burns; and mechanical and/or equipment problems and unavailability of immediate medical attention in case of injury. Furthermore, Bonvoyage Snow Adventures LLC (BVSA) employees' have difficult-jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

- 2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks. Initial here
- 3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless BVSA from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of BVSA's equipment or facilities, including any such claims which allege negligent acts or omissions of BVSA. - 4. Should BVSA or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. Initial here
- 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have. Initial here

In the event that I file a lawsuit against BVSA, I agree to do so solely in the state of Connecticut, and I further agree that the substantive law of Connecticut shall apply in that action without regard to the conflict of law rules of that state. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining document shall remain in full force and effect. Initial here
